


Introduction


The email facility within GMS enables the administrator to determine who is sent an email, who is copied into that email and more importantly who will and won't be receiving the email. It gives the administrators at the club an element of control over the email that are sent from GMS. Ensuring the right people get the communication and don't miss out.

There are two different scenarios for emailing members:

- Emailing Members, Parents, Coaches, Volunteers Anyone above the age of 18
- Emailing Youth Emailing Youth Players/Parents at the club
- Emailing Members/Parents (Any above the age of 18)
 Select People and Everyone, (this feature is available from any grid) Select the individuals(s) to email and Email



An email template is generated, detailing the following, once compete, select Send



A confirmation page appears upon sending, the details outline emails that were sent successfully and any emails that have been excluded. An example of this would be where an individual is a minor (Under 18) and does not have parents details linked to their record, so the email cannot be sent to the minor in isolation.



2. Emailing Under 18's

Select anyone under the age of 18 or groups of individuals that include individuals that contain under 18's and select email.



2.1 Sending to Youth

The email template will load, providing the administrator with an array of information about the recipients and who will and won't be receiving the email. There are multiple ways to tailor the email, such as:














Selection Summary – Total number of individuals selected

Youth Safeguards

- 1. How many selected are Youth and %
- 2. Send Youth Emails to If Youth is selected, the Parents are CC'd. If no parent link exists for the child, the email will still be sent to the email address linked to the child

Data Analysis – Contains information about the individuals selected (recipients), including:

- 1. Records without an email address Who won't receive the email
- 2. Youth without parental links Youth that will get an email, but don't have parents linked to their record so the parent will not receive the email too
- 3. Adults with no email Adults that won't receive the email
- 4. Youth Records with no email As above, but specifically Under 18's
- 5. Parents with no email Parents that are linked to Under 18 records that don't have an email

- 290 Number of email addresses
- 210 Number of recipients that are Adults
- 54 Number of Youths
- 26 Parents (linked to Youth Records)
 - The parental header has been removed and only the email body exists. The email is not going to Under 18's


